

# AGM 2016 – CLUB CAPTAIN’S REPORT<sup>1</sup>

## INTRODUCTION

My report last year began by stating we have had a demanding and eventful year with the Club moving forward in a positive and determined way. That goes for this year too. Moving into the new Club Structure with a Club Manager in charge has proved to be a highly successful step in the right direction. Shona Reid has done (is doing) an excellent job. Shona knows Club procedures inside out and shows an amazing ability to simultaneously keep on top of a whole range of issues and demands. We are indeed very fortunate to have her excellent services. Office-bearers and Committee members endeavor to support Shona in the exercise of her responsibilities and that will continue to be the case. ## FINANCE

A further significant enterprise in improving our Club Management structure has been to address the issue of a clearly obsolete Club Constitution. The process of review and revision has been well publicised. Members have been given ample opportunity to make comment on the proposed new Club Constitution. It is my hope members will support the proposal and allow us to test out the new

Competition events have run smoothly despite the fact that we are without a formal Match Secretary at present. Thanks to Roger Addison and our CM for carrying out these tasks on an ad hoc basis and for the volunteers who have closed the competitions. The staffing and stocking of the Club Pro Shop is an integral part of running competitions and we are indebted to a team of regular workers, both staff and volunteers, for all that they do. I repeat again this year my special thanks to Donald Webster for his constant and ubiquitous support. Thanks to Oliver Philip in shop duties and to all those who cover the shop on a voluntary basis.
